
OUR HISTORICAL JOURNEY AS FIRST NATIONS PEOPLE



Pre-Contact Era

Sovereignty & Nationhood

Our ancestors had sovereignty; they lived on their own here on their lands since time immemorial. Our ancestors were self sufficient; they did not rely on outside help prior to European contact.

Our people were self sufficient; they survived on their land since time immemorial; they believed that the Creator placed them on this land as a gift and that they are to take care of it

Our people lived off the land, in harmony with nature, taking only what they needed, and always acknowledging the gifts from the land, as being from the Creator; our connection with the land was spiritually based

Self Governance

"government under control and direction of the inhabitants of a political unit rather than by an outside authority... Control of one's own affairs" (Webster dictionary)

Our ancestors had self governance: they governed themselves based on natural laws – their spiritual connection to the Creator

Traditional governance is based on the spiritual connection to the Creator (sacred teachings)

Spiritual Foundation


For our ancestors, their spirituality was the foundation as to how they lived.

Their traditional systems were based on their spiritual beliefs on how they believed the Creator wanted them to live.

Governance was based on their belief in the Creator, and the natural laws were followed.

Everyday life was spiritual: always acknowledging the Creator in decision-making and all of Creation for the gifts they received (all of life was a ceremony)



COLONIZATION

"when various European nations explored, conquered, settled, and exploited large areas of the world... spreading European institutions and culture..." (Encyclopedia Britannica)

Governments from other lands come to take over another nation's lands; these new governments are called "settler governments"



Settler Government Laws

Indian Act

- main law affecting Native people
- passed in 1876 (based on policies already set out for Native people)
- its purpose was to control Native people
- Indian Act still exists today


Policies

- reserve system to gain access to lands through treaties
- residential school system to assimilate Native people, to destroy Native culture

Impacts of Government Laws

Reserve System

- We lost all our lands
- Treaties were signed between government and First Nations people (see attached map showing treaties)
- Government's view of treaty: we were giving up our lands
- Our people had a different understanding of the treaty: we believed we were agreeing to live in harmony with settlers and that our lands would be shared





Impacts of Government Laws

Residential School System

- Used as a way to assimilate Native people to become like Europeans
- Government believed the best way to do this is through the children
- For over 100 years, Native children were taken from their families and raised in residential schools

This has had devastating impacts on us:

- loss of culture and language
- Identity
- Dignity
- Parenting skills
- Family breakdown

Loss of Spiritual Foundation

Our traditional society was based solely on our spiritual connection to the Creator; we lived by natural laws, all of which were spiritually based

Our spiritual foundation is what the government attacked, because it was what made us strong, proud and independent

Our spirituality was outlawed for over 100 years; it was against the law to follow our ancestors' ways

Majority of our people lost their spiritual foundation; we became assimilated into European culture

Dependency Syndrome

Loss of self-reliance has resulted from years of colonization

Dependency on the government has become a syndrome

How did this happen?


- Relocation to reserves
- Indian Act restricting and controlling us
- Welfare system

Symptoms of Oppressed People

Addictions

 many of our people turn to alcohol and drugs, to numb themselves, many are not aware of why they do this

Lateral violence

 we turn on each other, instead of fighting against the government for our rights, we fight each other

Suicides

 hopelessness leads to suicide, many youth turn to suicide

Grief and Loss Symptoms

Overwhelming losses over a long period of time; a general state of apathy

Hundreds of years of losses will take some time to heal


We need healing and empowerment
